PLEASE READ CAREFULLY BEFORE SIGNING

This is a release of liability and waiver of certain legal rights.

In consideration for my being permitted to participate in the activities of **Warrington Sporting Clays**, I agree to the following Waiver and Release:

I acknowledge that hunting and /or clay target shooting has inherent risks, and hazards, and dangers for anyone, which cannot be eliminated, particularly in a wilderness environment. **I UNDERSTAND THAT THESE RISKS, HAZARDS, AND DANGERS INCLUDE BUT ARE NOT LIMITED TO:**

1. The risk of handling firearms and being near others that have firearms in their possession
2. The risk of ear damage from noise
3. The risk of injury from ammunition, clay targets and shot from other guns
4. Walking in rugged country, including encounters with wildlife, animals and insects
5. Inclement weather conditions.

Eye and ear protection are **REQUIRED** in the form of ear plugs and protective eye glasses. If I choose not to, I am doing so at my own risk.

I understand the risks, hazards, and dangers as described above and have had the opportunity to discuss them with **Warrington Sporting Clays**. I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe I do have that good physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities for my own safety as well as others. My participation in this activity is purely voluntary. No one is forcing me to participate and I elect to participate in spite of the risks. **I AM VOLUNTARILY USING THE SERVICES OF WARRINGTON SPORTING CLAYS WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS, OR DEATH.**

Lastly, I, for myself, my heirs, successors, executors, and subrogates, hereby **KNOWINGLY AND INTENTIONALLY WAIVE AND RELEASE, INDEMNIFY, AGREE TO DEFEND AND HOLD HARMLESS WARRINGTON SPORTING CLAYS**, its management, the land owner, officers, agents, employees, and volunteers from and against any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorneys' fees) which are related to, arise out of, or are in any way connected with my participation in this activity including, but not limited to, NEGLIGENCE of any kind or nature, whether foreseen or unforeseen, arising directly or indirectly out of any damage, loss, injury, paralysis, or death to me or my property as a result of my engaging in these activities or the use of these services, animals, or equipment, whether such damage, loss, injury, paralysis, or death results from negligence from anyone or from some other cause. I, for myself, my heirs, my successors, executors, and subrogates, further agree not to sue the land owner as a result of any injury, paralysis, or death suffered in connection with my use and participation in the activities of **Warrington Sporting Clays**.

I(WE) HAVE CAREFULLY READ, CLEARLY UNDERSTAND, AGREE TO COMPLY WITH, THE NRA SAFETY RULES, AND WARRINGTON SPORTING CLAYS GENERAL RANGE AND SAFETY RULES; AND VOLUNTARILY SIGN THIS WAIVER AND RELEASE AGREEMENT.
